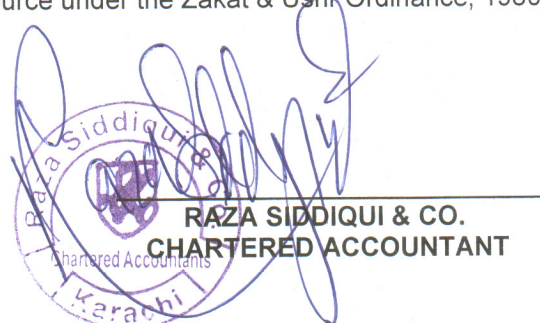
AUDITORS' REPORT TO THE MEMBERS
