| 06                                   | Any person aggrieved by decision of the Secretary General may, <b>within three days</b> of receipt of the decision, make a representation to the Election Commission which shall decide the representation <b>within three days</b> .   | Friday, August 05, 2022    |
| 07                                   | Any person, aggrieved by the decision of the Election Commission or in case the Election Commission fails to decide the representation within the period provided in sub-rule (6), may, <b>within three days</b> of decision by the Election Commission or, as the case may be, on expiry of limitation of the <b>Election Commission under sub-rule (6), make an appeal to the Regulator</b> who shall decide the appeal <b>within ten days</b> and his decision in this regard shall be final.                | Monday, August 15, 2022    |

| 13       | <b>Within two days</b> of decision of the Election Commission or in case the commission fails to decide within the stipulated time provided in sub-rule (12), any candidate, aggrieved by the decision of the Election Commission or, as the case may be, on expiry of limitation of the Election Commission under sub-rule (12), may file an appeal to the Regulator, who shall decide it <b>within seven days</b> and his decision in this regard shall be final. | Tuesday, August 30, 2022      |
