02	Within three days of the announcement of the election schedule member-firms desiring to change their representative shall intimate changes regarding name of representative to the Secretary General along with necessary proof of eligibility.	Saturday, July 16, 2022
03	The Secretary General of trade organization shall display, within seven days of the announcement of election schedule, the provisional list of all members eligible to vote along with their national tax number, sales-tax-registration number, if applicable, the name and national identity card number of their representative. The list shall be displayed at- (a) notice board of the head office and regional offices of the trade organization; and (b) website of the trade organization.	Friday, July 22, 2022
04	The members who have any objection to the entries in the list of voters shall send their objections in writing to the Secretary General within seven days of the issuance of the voters list.	Friday, July 29, 2022
05	The Secretary General shall, within five days from receipt of objections under sub- rule (4), intimate action on the objections or changes, if any.	Tuesday, August 02, 2022
	Any person aggrieved by decision of the Secretary General may, within three days of receipt of the decision, make a representation to the Election Commission which shall decide the representation within three days.	Friday, August 05, 2022
07	Any person, aggrieved by the decision of the Election Commission or in case the Election Commission fails to decide the representation within the period provided in sub-rule (6), may, within three days of decision by the Election Commission or, as the case may be, on expiry of limitation of the Election Commission under sub-rule (6), make an appeal to the Regulator who shall decide the appeal within ten days and his decision in this regard shall be final. 08	Within two days of the decision of the Regulator the final voters list shall be- (a) displayed at notice board of the office; (b) displayed at website of the trade organization; and (c) submitted to the Regulator:	Wednesday, August 17, 2022
N o A p e a I	Provided that if no appeal has been filed to the Regulator the final list of voters shall be displayed within fifteen days of the decision of the Election Commission under sub-rule (6).	Saturday, August 20, 2022

	Within four days of display of the final list of voters, any person, who is eligible to contest Elections for the vacant post, shall send his nomination, duly proposed and seconded by a duly registered voter and signed by the candidate, to the Secretary General.	Wednesday, August 24, 2022
10	Within twenty-four hours of receipt of nomination papers, a copy of the final list of voters shall be provided to each contesting candidate.	Thursday, August 25, 2022
11	The nomination papers shall be scrutinized by the Election Commission and list of candidates shall be displayed within twenty-four hours of the last date of receipt of nomination papers.	Friday, August 26, 2022
12	The objections, if any, to nomination of the candidates may be filed to the Election Commission within twenty-four hours of issuance of the list of candidates, which shall be decided by the Election Commission within two days.	Saturday, August 27, 2022
13	Within two days of decision of the Election Commission or in case the commission fails to decide within the stipulated time provided in sub-rule (12), any candidate, aggrieved by the decision of the Election Commission or, as the case may be, on expiry of limitation of the Election Commission under sub-rule (12), may file an appeal to the Regulator, who shall decide it within seven days and his decision in this regard shall be final.	Tuesday, August 30, 2022
14	Within two days of the decision of the Regulator the Election Commission shall issue final list of the candidates: Provided that if no appeal has been made to the Regulator, final list of the candidates shall be issued within eleven days of the decision of the Election Commission under sub-rule (12). 16	Within two days of the polling as provided in sub-rule (15), any person elected as member of Executive Committee, shall send, to the Election Commission for election as an office bearer, his nomination duly proposed and seconded by an elected Executive Committee's member and signed by the candidate. 17	The nomination papers shall be scrutinized by the Election Commission and list of candidates shall be displayed within twenty-four hours of the last date of receipt of nomination papers.	Saturday, September 10, 2022

	Within two days of display of final list of the candidates, the polling for election of office bearers shall be held at Association Secretariat, ST-7, Block-22, F.B. Industrial Area, Karachi	Wednesday, September 14, 2022
